- 二、設置宗旨：關鏞大使為回饋母校並鼓勵輔大外語學院清寒學生努力向學，服務社會人群，設置「輔仁大學外語學院關鏞大使清寒獎學金」以嘉惠莘莘學子。
- 三、設置方式：捐款新臺幣100萬元，成立永續基金專戶，以當年度孳息作為獎學金，本金永不動用。
- 四、獎學金金額：每學年每名新臺幣壹萬元整。
- 五、獎學金名額：每年1名。
- 六、申請時間：每學年自10月1日起至10月15日止向本院秘書室申請。
- 七、申請資格：

Guidelines for the Establishment of the Ambassador Guan Yong Scholarship for Low Income Students

Passed by the 6th College of Foreign Languages Management Meeting of the 2011 academic year on June 1, 2011
Passed by the 6th College of Foreign Languages Management Meeting of the 2024 academic year on December 26, 2024

- I. Purpose: To give back to society and Fu Jen University as well as encourage students of low-income backgrounds who display diligence in academic study, the Ambassador Guan Yong Scholarship for Low Income Students is thus established.
- II. Establishment: A one-time donation of NT\$1 million to a sustainable fund, of which the yearly interest will serve as the scholarship for that year; the capital of said fund may not be used.
- III. Scholarship Amount: NT\$10,000 per student per academic year
- IV. Number of Recipients: One recipient per academic year
- V. Application Window: Applications accepted at the Office of the Secretary of the College of Foreign Languages each academic year from October 1 to October 15
- VI. Eligibility:
 1. Graduate or undergraduate students currently enrolled at the College of Foreign Languages
 2. Must be from a low-income household
 3. To encourage students to actively pursue their studies and give back to society, recipients of this scholarship should participate in activities or courses with educational significance and receive relevant guidance and counseling.
- VII. Required Documentation:
 1. Application Form
 2. Detailed self-introduction
 3. Household Registration Transcript for all family members (Household Register not accepted)
 4. Official documentation from the National Taxation Bureau of Taiwan detailing one complete year of individual income tax for all family members
 5. One (1) letter of recommendation from an advisor or teacher
 6. Submit a one-page learning reflection report.
- VIII. Review Process: Review will place primary emphasis on family background, moral conduct, and academic performance, and will be conducted by the Management Meeting of the College of Foreign Languages.
- IX. Information included in the application of this scholarship will not be returned to applicants.
- X. These Guidelines have been passed by the Management Meeting of the College of Foreign Languages and will be announced and made effective upon the approval of the University President. Any amendments to the Guidelines will be announced and made effective in similar fashion.
